Notes to Consolidated Financial Statements - Unaudited For the Years Ended December 31, 2021 and 2020

## **Summary of Significant Accounting Policies**

## (a) Description of Business

FieldCore Servie Solutions International, LLC (FSSI), known as the Company, is primarily engaged in providing technical and manpower support services

## (b) Principles of Consolidation

The consolidated financial statements include the financial statements of FSII, its wholly owned subsidiaries and the international branch offices of FSII. All significant intercompany balances and transactions have been eliminated in consolidation.

## (c) Translation of Foreign Currency

As part of the consolidation of the Company, the financial statements of FSSI have been translated to U.S. dollars in accordance with the provisions of ASC 830, Foreign Currency Translation. Assets and liabilities are translated at the current exchange rate at the balance sheet date. Results of operations have been translated using the average rate prevailing throughout the periods presented. The foreign currency translation adjustments are recorded as a separate component of shareholder's equity.

#### (d) Revenue Recognition

Revenue from services related to short-term projects, together with the related cost of these services, are recognized when the services are rendered. Cost of services consists of salaries and benefits, related payroll taxes and workers' compensation insurance, as well as raw materials. Unbilled revenue consists of the labor services that have been rendered but have not been billed to the customer.

#### (e) Cash and Cash Equivalents

The company considers all highly fluid debt instruments and marketable securities purchased with the original maturities of three months or less to be cash equivalents.

## (f) Depreciation and Amortization

Property and equipment are carried at cost and are depreciated on a straight-line basis. The following depreciable lives are used:

## (g) Income taxes

The domestic operations of the Company are included in GE's consolidated U.S. and certain state and local tax returns. In general, non-U.S. income tax returns are filed for the Company's international operations on a stand-alone basis. For purposes of these financial statements, the Company's tax provision has been prepared on a separate return method. Under this method, income tax expense has been determined by applying ASC 740, Accounting for Income Taxes, to the Company as if it were a separate taxpayer. Deferred tax assets and liabilities are prepared using the asset and liability method and are recognized for the future tax consequences attributable to differences between the financial statement carrying amounts of existing assets and liabilities and their respective tax bases. Deferred tax assets and liabilities are measured using enacted tax rates expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled. The effect of changes in tax rates is recognized in the period that includes the enactment date.

## (h) Comprehensive Income

Comprehensive income consists of net income and the foreign currency translation adjustment and is presented in the consolidated statements of shareholder's equity and comprehensive income.

## (i) Use of Estimates

Management of the Company has made a number of estimates and assumptions relating to the reporting of assets and liabilities and the disclosure of contingent assets and liabilities, and the reporting of revenues and expenses, to prepare these consolidated financial statements in conformity with accounting principles generally accepted by the United States of America. Significant items subject to such estimates and assumptions include accruals for health insurance and workers compensation costs for which the company is self-insured and the carrying amounts of intangible assets. Actual results could differ from those estimates.
